1. 重要な会計方針 Important accounting policy

財務諸表の作成は、NPO法人会計基準(2010年7月20日 2017年12月12日最終改正、 NPO法人会計基準協議会)によっています。The statement of revenue and expenditures is prepared based on Specified Nonprofit Corporation accounting standards (amended in 20 July 2010 and 12 December 2011).

- (1) 棚卸資産の評価基準及び評価方法 Evaluation standard and assessment procedure of inventories 最終仕入原価法を採用しております。 Last purchase price method is adopted.
- (2) 固定資産の減価償却の方法 Depreciation of fixed assets

有形固定資産の減価償却方法は定率法(但し平成10年4月1日以降に取得した建物は定額法)、リース資産については、リース期間定額法を採用し、耐用年数は税法基準を採用しております。Depreciation of tangible fixed assets is calculated by the declining-balance method (except for buildings acquired on or after April 1, 1998 using the straight-line method). Regarding leased assets, lease term straight-line method is adopted and income tax basis is adopted for estimating durable years of leased assets. Income tax basis is adopted for estimating durable years of assets.

(3) 引当金の計上基準 Standard for reserve

退職給付引当金 Accrued employees retirement benefit

退職給付引当金は期末在職職員の「自己都合による退職時の要支給額(100%)」を計上しております。100% of necessary payment for tenure staff at the end of period is allocated as accrued employees retirement benefit.

(4) 外国通貨の換算方法について Conversion of foreign currency

外貨建取引については各月の平均レートにより円換算しております。Conversion of foreign currency to Yen during period is based on monthly average rate of XE.COM INC. of its currency.

外国通貨及び外貨建金銭債権債務については期末日のレートにより円換算しております。Foreign currencies and monetary assets and liabilities denominated in foreign currencies were converted to Yen based on the currency rate of XE.COM INC. of the last date of the fiscal year of Peace Winds Japan.

(5) 施設の提供等の物的サービスを受けた場合の会計処理 Accounting procedure when receiving physical services such as provision of facilities

※1 美術品の評価見直しについて Reassessment of Art work

2015年にゲルハルト・リヒター氏から寄贈された美術作品について、本年度、資産価値の評価を受けたため、修正益として計上しました。寄贈当時は、価値の算定が難しいとされたため、作品の制作・設置および建物の建設にかかった実費のみを資産とし て計上しておりました。しかし、その後、一般公開等を通じて作品が多くの関係者に知られ、美術的な価値をより客観的に評価することが可能になったことから、地域創生のシンボルとして今後さらなる活用を図るためにも、専門家による査定を受け入れること としました。美術品の価値は、作家に対する一般的評価に当該作品の独自性、希少性等を加味して算定されるため、評価を受けた2018年度において美術品として資産計上しております。

The asset value of the art work donated by Mr. Gerhard Richter in 2015 was appraised in this business term; therefore, its calculated value is recorded as the profits from previous term adjustments. At the time of donation, only the actual costs for the installment of the art work as well as the construction of the exhibition hall were recorded as assets due to the difficulty of appraising the asset value of the art work. However, after the several years of exposure of the art work to the public with its emerging recognition, PWJ acknowledged the opportunity for objective appraisal of the art work and thus received the expert assessment, aiming at the art work's further contribution as a symbol of the regional revitalization. Since the value of an art work is calculated by taking into account the uniqueness and rarity of the art work in a general evaluation of the artist, PWJ recorded the calculated value of the donated art work as "Art work" in this business terms of 2018 when the art work was appraised.
